#### **Guidance Notes**

#### **Heating Fitter JIB-PMES CSCS Registration Card (Gold)**

- i. A Gold JIB-PMES CSCS Registration card is issued to those who hold any of the following NVQ Diploma; NVQ/SVQ or equivalent qualifications:
  - Level 3 NVQ Diploma in Domestic Heating
  - Level 3 NVQ Diploma in Heating & Ventilating (Industrial &Commercial) Installation
  - Level 3 NVQ Diploma in Planned & Reactive Maintenance on H&V Equipment
  - City & Guilds Level 3 NVQ in MES Heating & Ventilating Installation (Domestic/Industrial & Commercial)
  - City & Guilds Level 3 NVQ in MES Heating & Ventilating Maintenance of Systems Components
  - City & Guilds 597-2 Advanced Craft Heating & Ventilating Fitting
  - City & Guilds 604-2 Advanced Craft Heating & Ventilating Fitting
  - City & Guilds Advanced Craft Certificate in Domestic Heating and Ventilating
  - City and Guilds Level 3 6008, 6018 or 6088 NVQ in Heating & Ventilating (Domestic)
  - City and Guilds Level 3 6188 NVQ Diploma In Heating and Ventilating
  - City & Guilds 6189-41 Level 3 NVQ Diploma in Domestic Heating
  - BPEC Level 3 NVQ Diploma in Domestic Heating
  - EAL Level 3 NVQ Diploma in Domestic Heating

A gold JIB-PMES CSCS Registration card is also issued to those who achieve the Building Services Engineering Craftsperson Apprenticeship Standard. For those who achieve the Apprenticeship Standard, the grade they achieve (i.e. Pass, Merit or Distinction) will also appear on the reverse of the card.

Please note: VRQ certificates (C&G 6128 Technical Certificate; C&G Diploma or equivalent BPEC and EAL qualifications) are not acceptable.

- ii. JIB-PMES CSCS Registration cards issued on this basis are valid for up to five years and may be renewed after that period (subject to renewal rules).
- iii. This route of entry is permanently open.
- iv. Those who have achieved their NVQ Diploma or NVQ/SVQ less than two years before applying for their JIB-PMES CSCS Registration card do not need any further health and safety training/testing to obtain the card, until the card needs renewing.

The achievement of a relevant NVQ Diploma or NVQ/SVQ is accepted as evidence of health and safety awareness.

Note: The exemption period is for a maximum of 2 years from the date on the completion certificate.

- v. To obtain a Heating Fitter (Gold) JIB-PMES CSCS Registration card, applicants must provide the following:
  - A correctly completed application form plus appropriate fee.
  - A copy of the Level 3 NVQ Diploma, Level 3 NVQ/SVQ, Building Services Engineering Craftsperson Apprenticeship Standard Completion Certificate or City & Guilds Advanced Craft Certificate.
  - Evidence of completing appropriate Health, Safety and Environment training.
  - Evidence of working within the Plumbing and Mechanical services industry.

IF YOU HAVE COMPLETED THE LEVEL 3 PLUMBING TECHNICAL CERTIFICATE (CITY & GUILDS 6128) OR A LEVEL 3 DOMESTIC HEATING DIPLOMA (CITY & GUILDS, EAL OR BPEC EQUIVALENT QUALIFICATIONS) AND ARE NOT CONTINUING YOUR STUDIES ONTO THE LEVEL 3 NVQ DIPLOMA INHEATING AND VENTILATING (C&G 6188) OR A LEVEL 3 NVQ DIPLOMA IN DOMESTIC HEATING (CITY & GUILDS 6189-41, BPEC OR EAL EQUIVALENT QUALIFICATIONS), THE ONLY CARD YOU WILL BE ELIGIBLE TO APPLY FOR IS THE LABOURER CARD.

IF YOU ARE CONTINUING WITH YOUR STUDIES, YOU WILL NEED TO APPLY FOR A RED TRAINEE CARD.

Note: NARIC equivalence reports

- vi. Those applying for cards by providing NARIC equivalence reports are also required to provide a copy of valid photographic identification (e.g. Biometric Residence Permit or Passport). This should be included at the time of application along with the NARIC equivalence report. Failure to submit a copy of valid photographic ID with the application form will result in the application being returned to the applicant.
- vii. Those applying for a Heating Fitter gold card must provide a full NARIC 'Statement of Comparability for Construction Skills' including Primary Source Verification. The JIB-PMES no longer accepts standard NARIC 'Statements of Comparability' in support of Heating Fitter gold card applications.
