#### **Guidance Notes**

#### PMES Related Occupation - Skilled Operative CSCS Registration Cards (Blue and Gold)

- i. A Blue UK-PHMES CSCS Registration Card is issued to those who have achieved either a Level 2 NVQ Diploma or an equivalent Level 2 qualification (i.e. City and Guilds Craft Certificate).
- ii. A Gold UK-PHMES CSCS Registration Card is issued to those who have achieved either a Level 3 NVQ Diploma or an equivalent Level 3 qualification (i.e. City and Guilds Advanced Craft Certificate).

PLEASE NOTE: The exact requirements and details of acceptable qualifications for each occupation are listed on the JIB-PMES website. It is ESSENTIAL that applicants check their qualifications against these requirements before applying as application fees are non-refundable.

- iii. UK-PHMES CSCS Registration Cards issued on this basis are valid for up to five years, and may be renewed after that period (subject to renewal rules).
- iv. These routes of entry are permanently open.
- r. To obtain a Blue or Gold JIB-PMES Skilled Operative CSCS Registration Card, applicants must provide the following:
  - A correctly completed application form plus appropriate fee (payable at time of application)
  - A copy of the Level 2/3 NVQ Diploma, Level 2/3 NVQ/SVQ, City & Guilds Craft/Advanced Craft Certificate or other applicable qualification as may be acceptable to the JIB-PMES (see guidance at <a href="https://www.jib-pmes.org.uk">www.jib-pmes.org.uk</a>)
  - Evidence of passing an appropriate Health, Safety and Environment assessment
  - Evidence of working within the Plumbing and Mechanical Engineering Services industry or a related trade.

#### Note: NARIC/UK-ENIC equivalence reports

- vii. Those applying for cards by providing NARIC/UK-ENIC equivalence reports are also required to provide a copy of valid photographic identification (e.g. Biometric Residence Permit or Passport). This should be included with the application along with the appropriate NARIC/UK-ENIC report. Failure to submit a copy of valid photographic ID with the application form will result in the application being returned to the applicant.
- viii. Those applying for cards by providing NARIC/UK ENIC reports are NOT eligible to claim the NVQ/SVQ Health, Safety and Environment test exemption.
