Guidance Notes

JIB-PMES CSCS Registration Card for Plumbing/Heating/Gas Fitting & Mechanical Pipefitting Trainees

- i. The Trainee card is available for both new entrant and experienced workers who meet the following criteria:
 - Those with or without prior experience who are registered for an appropriate NVQ Diploma; NVQ/SVQ or acceptable Diploma Level 2 or 3
 qualification (but who have not yet achieved) and are employed in the plumbing and mechanical engineering services industry.
 - Those without prior industry experience who intend to register on an appropriate NVQ Diploma; NVQ/SVQ or acceptable Diploma Level 2
 or 3 qualification within 12 months of signing this application form and who have signed a declaration with their employer confirming
 this.
 - Acceptable qualifications for each occupational area include those listed below:
 - 1. Plumbing -
 - 1. Level 2 NVQ Diploma in Plumbing and Heating (C&G 6189-11; BPEC or EAL equivalent qualifications)

- ii. It acts as an identification card during on-site training periods.
- iii. It shows that the cardholder is or is to be registered on an NVQ Diploma or NVQ/SVQ appropriate to his/her occupation, but has not yet completed.
- iv. Before a Trainee card can be issued the applicant must provide the following:
 - Details of the course/qualification the learner is enrolled on, including the signed endorsement of their course tutor Or
 - Confirmation of the Employer and Trainee of the intention to start on a formal course/qualification within 12 months of signing this application form.
 - Confirmation of completing the appropriate health and safety units from the qualification

Or

- Confirmation of completing the CITB Health, Safety and Environment test for operatives.
- v. Trainee cards are valid for up to five years, or until the card holder is eligible for a Blue or Gold Card relevant to their occupation.

Please note students registered on C&G 6035 (VRQ) technical certificate or other equivalent courses who are not continuing their training to obtain a full qualification are not eligible for this card.
