

JIB-PMES Death in Service Benefit – Nomination form

Introduction

Death in Service Benefit is provided as part of your JIB-PMES Participant Employer welfare benefits. For as long as your employer continues to either:

- a.) Purchase Holiday credits on your behalf
- Or
- b.) Purchase welfare benefits on your behalf

...you will be covered under the JIB-PMES Death in Service Benefit scheme.

This means that in the event of your untimely death (of any cause, at any time) your family/estate will benefit from a payment of £40,000, providing your employer has kept up to date with the above payments. The purpose of this form is for you to tell us who you would like the Death in Service Benefit to be paid to.

Nomination Form information

Death in Service Benefit (DSB) is paid directly to your nominated recipients. You should note however, that while the JIB-PMES will give every consideration to your wishes, your nomination is not legally binding on the JIB-PMES.

You can change your mind regarding who your Nominated Beneficiary(s) is/are; but please make sure that you sign and date a new Nomination Form and return it to the JIB-PMES each time any changes are made.

If you do not nominate a recipient/recipients then any payment that is due, following your death, will be made to your estate. Additional copies of this form should be requested from your JIB-PMES Participant Employer.

It is essential that you retain a copy of this completed form for your own records.
